- Maintain daily attendance records according to program and licensing standards
- Rotate and display books and toys in engaging ways while ensuring a clean playroom
- Understand and adhere to all required policies and procedures including agency safety

- Brain Story certification required
- Familiar with Flight: Alberta's Early Learning and Care Framework
- Knowledge of family violence and trauma-sensitive approach is an asset
- Police Check with Vulnerable Sector Search and a cleared Child Intervention Check required
- Physical ability to sit, bend, kneel and lift up to 30 lbs while interacting with children
- Physical capability to supervise and play outdoors with children.
